

IDF_01 'Participative governance framework for the update of the regional SUMP'

Objectives of the measure

At measure level:

- To generate discussion and create a space for different stakeholders to actively exchange and participate on the SUMP update
- To allow discussion between actors that usually don't meet often as their mission do not often overlap.

Contributing to city level objectives of:

- The target at Versailles Grand Parc's level is to connect in a better way with relevant stakeholders in the SUMP creation process and also to better connect with the transport authority to better take into consideration the measures led on the Versailles Grand Parc territory to include them in the work of Institut Paris Region when updating the regional SUMP conducted by the Transport Authority (Île-de-France Mobility), expected in 2024, and called "PDM" (Plan de Mobilité).

Description of the measure

Situation before:

Before the measure, the SUMP is developed with direct implication of impacted territorial entities. But, as in every public consultation, it can be tricky for one's voice to be heard alongside others. And it is a territorial battle to have specific territorial measure to be implemented in the SUMP to get support from the Region. This measure is important in regard of the Region administrative organisation, as Île-de-France is fractioned in a lot of different entities, at different level of action, with different levers to act on mobility. These entities are taking part in the SUMP conception and are impacted by its measures, so enhancing exchanges is important.

General description:

The aim would be for Institut Paris Region, as we are taking part in the evaluation and in the development of the new SUMP, to open a privileged channel between Versailles Grand Parc and the relevant instances at regional level to connect or even integrate Versailles Grand Parc's measure in the SUMP.

To do that we will help relevant actors from both sides to meet:

- At the Ateliers du PDM (urban mobility plan workshops)
- Organise a work seminar between the transport authority, VGP and any other actors that may be relevant for VGP to fulfil their project (transport authority, Region...)
- And more generally we will be the bridge between VGP and the Regional instances

Measure outputs:

As it is a measure that aims to facilitate exchanges between actors at different level and with very different aims, the measure outputs are difficult to quantify or to be put in numbers. The measure will be fulfilled if we allow actors that usually don't meet often to discuss such matters to meet and to find themselves common interests and goals. In that vein, outputs could be incarnated in:

- The organisation of some Ateliers du PDM (urban mobility plan workshops)
- The organization of a work seminar between the transport authority, VGP and any other actors that may be relevant for VGP to fulfil their project (transport authority, Region...)
- Creating better participative governance framework
- Developing good practices and know-how guidelines to achieve better dialogue between actors

Supporting activities:

As the objective is to enhance the communication between actors, we would implement a privileged team to work together and a privileged space to exchange. Our goal would be to pair someone at transport authority and at regional level with someone at VGP level so that there is always a channel open between them.

Interaction with other city measures: UPPER and non-UPPER measures

This measure is important as it will have an impact on all others. Having a good dialogue between VGP, the transport authority and the Region is crucial to some of our other measures (for example in terms of data sharing, or in terms of authorisation to use certain data).

Target groups and/or geographical impact areas

Target groups:

All the stakeholders that take part in the regional SUMP process, all the local stakeholders that take part into Versailles Grand Parc's measures, the transport authority.

Geographic implementation area:

Irrelevant in our case.

Stakeholders

The following stakeholders will be required for the implementation of this measure.

- VGP: UPPER project territory of implementation
- Instant Systems: They work in close collaboration with Île-de-France Mobilités, especially on IDF PT itinerary calculator.
- Region : In charge of the transport authority of Île-de-France
- Île-de-France Mobilités: Regional transport authority. In charge of all public transports aspects at regional level and at a more local scale when needed.
- **Départements et communes:** other levels of governance which detains transport aspects (but with whom VGP is already well used to work with.
- Institut Paris Region: In the case of this measure, bridge between VGP and the regional level actors

U-tools support

This measure will not be actively supported by any IT tool of the UPPER toolkit.

Link to other UPPER measures

This measure is similar to UPPER measures implemented in other cities, especially:

- MAN_01: Establish participative governance and dialog formats to address the citizens with a focus on the (special) needs of user groups
- LIS_03: To improve the mobility planning
